## 1 INTRODUCTION

The purpose of this document is to outline the procedure and requirements for suppliers ("Seller") to submit deliverable documentation and/or data items ("Documentation") for Orders issued by General Atomics (GA) in support of General Atomics Electromagnetic Systems (GA-EMS) Group ("Buyer"). As specified in the Order, Seller shall submit all Documentation required under the Order according to the instructions herein.

## 3 REQUIREMENTS

- 1) All Documentation shall be submitted to Buyer prior to delivery per Appendix B of 09492L00008 as required.
- 2) After submitting Documentation send an e-mail to EMS\_CM@GA.com informing that the Documentation has been submitted.
- 3) All correspondence with GA-EMS Configuration and Data Management (CDM) using submittal methods 1) and 2) shall include the following:
  - Seller's contact information
  - Buyer's Order number
  - Buyer's Statement of Work (SOW) number (if applicable)
  - Buyer's Authorized Purchasing Representative's full name
- 4) Unless otherwise specified in the Order, the Documentation listed shall be legible and accessible in one of the formats specified below:
  - Reports, presentations, spreadsheets – Compatible with Microsoft Office 2007
  - Schedules – Compatible with Microsoft Project 2010
  - Electronic drawings – Readable with Adobe Acrobat Reader 9.0
- 5) Seller shall:
  - Provide all applicable passwords to unlock and/or unprotect Documentation
  - Ensure no Documentation contain proprietary or restrictive markings
  - Resubmit any Documentation rejected by Buyer after sufficient rework using one submittal methods (above).

- 6) In some instances, it may be permissible to reuse certain Documentation previously approved by Buyer under a prior Order. In such instances, Seller shall obtain prior written approval from Buyer *before data reuse submission*. Seller shall submit all requests for data reuse to GA-EMS CDM with a copy to Buyer's Authorized Purchasing Representative specified in the Order. Seller shall use the most current version of Form EMS-0364 for all data reuse requests, which can be obtained from Buyer's Procurement website at:

#### **4 SUBMITTAL METHODS**

Seller shall submit all Documentation specified in the Order to GA-EMS CDM electronically with concurrent notification to Buyer's Authorized Purchasing Representative specified in the Order using one of the following secure methods:

- 1) **Electronic File Transfer Protocol:** Contact GA-EMS CDM at EMS\_CM@GA.COM to setup an account. This is Buyer's preferred method.
- 2) **ProjectLink:** Contact Buyer's Authorized Purchasing Representative to initiate an upload.

**NOTE:** Distributors may provide documentation specified by the Order with the shipments, except noting that Distributors of raw material shall comply with QC 259 when specified in the Buyer's Order.
